BYLAW 2020-07 VILLAGE OF BEISEKER **TAXATION BYLAW 2020**

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITH THE VILLAGE OF BEISEKER FOR THE 2019 TAXATION YEAR.

WHEREAS, The Village of Beiseker has prepared and adopted detailed estimates of the municipal revenue, expenses and expenditures as required, at the council meeting held on June 08, 2020

WHEREAS, the estimated municipal revenues from all sources other than property taxation total \$1,151,549.02, and

WHEREAS, the estimated municipal expenses (excluding non-cash items) set out in the annual budget for the Village of Beiseker for 2020 total \$2,047,476.11; and the balance of \$895,927.09 is to be raised by general municipal taxation.

NOW THEREFORE, under the authority of the *Municipal Government Act*, the Council of the Village of Beiseker in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Village of Beiseker:

- 1. That the minimum amount payable per title as registered in the Land Titles Office as property tax for general municipal purposes property tax shall be \$853.00.
- 2. That 2020 property taxes are due on September 30, 2020. A penalty of 10% of current taxes will be applied to any outstanding 2020 tax balances on October 1, 2020.
- 3. That a further 10% penalty on all outstanding taxes will be applied on January 1, 2021.
- 4. If any portion of this bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion must be severed and the remainder of the bylaw is deemed valid.
- 5. That this bylaw shall take effect on the date of the third and final reading.
