a) Airport Sale

Councillor Henuset made motion to advertise the sale of the Beiseker Airport for Seven hundred thousand dollars (\$700,000.00) plus GST or best offer and to use the advertisement of the sale of this public land as a means of determining fair market value as required by the MGA, since acquiring a proper appraisal for the land and operation was not possible nor financially feasible and comparisons of similar properties was also not achievable.

Councillor Lemky made motion to reject the offers to purchase the airport that have been received to date (April 13, 2020) since none of the offers amounted to the sale price set by Council.

Councillor King made motion to state that the Village of Beiseker has no preference as to whether the Beiseker Airport remains operating as an aerodrome should the property sell to another owner after it is sold by the Village of Beiseker. CARRIED

Deputy Mayor Ursu made motion to ensure that the advertisement for the sale of the Beiseker Airport be published for a minimum of thirty (30) days. CARRIED

a) Ministerial Order - Deferral of School Tax on Non-Residential Properties -COVID-19

Mayor Wise made motion to move the due date for all municipal and school taxes for the 2020 taxation year to September 30, 2020 thereby assigning the penalty date on current taxes to October 1, 2020. **CARRIED**

Councillor Lemky made motion to allow TIPPS (Tax Installment Payment Plan) customers to stay on the program from the period of April 27, 2020 to September 30, 2020 regardless if a payment is refused by their banking institution (NSF) in respect of the COVID-19 pandemic, however, all amounts owed for TIPPS customers will be recalculated after September 30th, 2020 so that all taxes are paid before December 31, 2020. **CARRIED**

b) 7th Street Bridge Signage

Councillor Henuset made motion to request that the businesses that have heavy vehicles using the 7th Street bridge are reminded again that the bridge has weight restrictions and that fines will be imposed on vehicles that are overweight, and that a message that states what the range of fines are for overweight vehicles is posted in the MainLine Express.
