Chris Heighton expressed his concerns about the run off from the spring melt and heavy rains. His property has flooded 3 of the last 6 years. This year he put out sandbags in February to stop the flooding of his property again. He suggests that the culvert by the public works shop is not large enough to handle the amount and speed of water that is entering the drainage ditch; this causes a backup and flooding of his property. He suggested that a larger culvert or an additional culvert be installed to handle the volume. Alternatively, raising the bank of the channel by approximately a foot, especially in the low area, would also keep the water within the drainage channel.
