Recommendation here was to have the sewer lines in the village videoed, as many of the lines are old and not of up to date materials. It was also estimated that additional anaerobic cells will need to be added to the lagoon in approximately 10 years. Page 39 summarized the storm sewer. The lift station should be assessed within the next few years. Drainage ditches and culverts need to continue to be maintained. Page 47 gives a summary of the roadways.
