DELEGATIONS:

Christine Camp and Brandy Schmidt residents of 7th Street inquired why 7th Street had not been swept and to advise that there are many potholes that need repair. Mayor Courtman advised that unpaved streets are not swept and that the pot holes would be repaired when it stops raining. They also advised Council that heavy vehicle traffic is common on 7th and discussed paving the street. They were told that paving had been proposed approximately 7 years ago but had been rejected by the property owners on 7th. They thanked Council for the information and left Chambers at 7:15

Fire Chief Ursu advised Council that the Fire Department now has 20 members and has attended 16 call outs since January. The Country Fair was a great success and many people were interested in checking out the new fire pumper. Approximately \$7,200.00 was raised through donations – Heighton restoration – 2300.; sale of hotdogs/hamburgers and t-shirts at Snag a Deal - \$1,862 and the pie auction of \$1,800.00. Just over \$20,000 total has now been raised for the new pumper. Council thanked the Fire Department and the Fire Association for all the hard work they are doing to raise funds for the truck. Chief Ursu left Chambers.

- The draining of the lagoon will be done closer to fall when the anaerobic cells are cleaned so that less water will have to be pumped by the contractor.
