The minutes of the last meeting were read and adopted.

The financial statement for the month ending December 31st 1946 was presented, discussed and signed by the Mayor. The statement is filed herewith.

The appointment of a Returning Officer came up for discussion. Tom Wagner, Secretary, was asked to act and consented to do so.

The following By-law was drawn,

The Council of the Village of Beiseker enacts as follows:-

That Tom Wagner, of the Village of Beiseker, be and is hereby appointed Returning Officer for the Village of Beiseker for the year 1947.

That the votes be polled in the office of the Secretary Treasurer.

The above By-law received its first, second and third reading and was finally unananimously passed.

The Secretary was instructed to post notices for annual meeting in accordance with Sec. 203 of the Town & Village Act.

The R. O. (Secretary) was also instructed to post notices in accordance with Sec. 205 of the Town & Village Act (Notice of Nominations).
