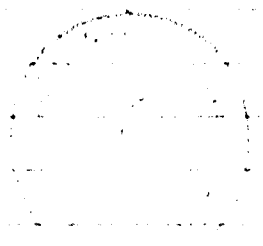
John Scheffelmaier was called in and engaged as skating rink caretaker at the rate of \$50.⁰⁰ per month.


