The minutes from the last meeting were read & moved by Louis Schmalz that the minutes be adopted as read. Carried.

It was moved by Louis A. Schmalz that the financial statement for May be approved & signed by the Mayor & Secy. Treasurer. Carried.

TENDERS

Moved by Leo Schmalz that in future tenders should be given out for the construction, repair etc. of roads & sidewalks where possible. Carried.

The Secy was instructed to prepare tenders for the building of sidewalks along the north side of 5th Street between 1st & 2nd Ave, & along the west side of Block 1 & from the corner of 5th St & 1st Ave to the Red & White Store. Specifications of these sidewalks were to be made up, & made available to the prospective contractors.

Several building ~~contracts~~ ^{permits} were granted as follows.

Moved by Adam Velber that Anton Hagel be granted a permit to construct a dwelling. Carried.

Moved by Leo Schmalz that the Zion United Church be granted a permit to move their church to town. Carried.

Moved by Louis Schmalz that Sam Kang be granted a permit to move a dwelling to the village. Carried.

Moved by Leo Schmalz that M.A. Bellin be granted a permit to repair his dwelling & construct a cess pool. Carried.

The School Board & the school trustee were in attendance to discuss the possibilities, pros & cons, of building a school in Beiseles. The Council agreed to give the decision its full support if & when they decided to build.

Moved by Adam Velber that the meeting adjourn.
