

THE MINUTES OF THE REGULAR MONTHLY MEETING OF THE COUNCIL OF THE VILLAGE OF BEISEKER HELD AUGUST 9, 1971 IN THE COUNCIL CHAMBERS.

MINUTES:

The minutes of the regular monthly meeting held June 14th were read and asopted as correct by Councillor Velker.

FINANCIAL STATEMENT:

The financial statements for the months of June and July were read and adopted as correct by Councillor Schmaltz subject to year end audit.

BUSINESS:

Mayor Schmaltz reported to Council that the new signs ordered by the Village were received and most of them were installed, some at the Park Gate and at various points in the Village.

Mayor Schmaltz also reported to Council that the loan at the Royal Bank in the sum of \$8000.00 was repaid. and also the requisitions were paid up to date.

The Calgary Power poles stored on Village property were discussed by Council and as these poles are treated, taxpayers in this area wished them removed. Secretary-Treasurer to write Calgary Power Limited requesting that this poles be removed. The Council also discussed the Calgary Power plan for 5 street lites to be installed on the main road into the Village. This was approved by Council. Mayor and Secretary to write Calgary Powe r of Council's decision and lites to be installed as soon as possible.

Mayor Schmaltz also reported that since the last Council meeting that a water restriction was put on users in the Village due to the hot and dry period of weather with the south side of the Village Monday, Wednesday and Friday and the North side of the Village Tuesday, Thursday and Saturday.
