CALL TO ORDER:

The meeting was called to order at 1:00 p.m. by Mayor Richter.

Deputy Mayor Benoit moved that Mayor Richter act as Chairman of the Court of Revision. Carried.

Two appeals were considered:

- (1) Larry Daubert - Lot 14 Block 4 Plan 1192FR
Complaint: assessment on improvements was for a double wide mobile home rather than a single wide.

John Davis informed the Court that this was due to an error at the time of the 1978 annual assessment and was corrected by the authority of Section 62(1) of the Municipal Taxation Act.

- (2) Alex Goodman
appeal of assessment on lots 9 & 10 Block 14 Plan 7711236

A letter from Mr. Goodman was read by John Davis.
Mr. Davis comments were:


- (a) Lot 9 is assessed lower than Lot 10 since it is smaller in size.
(b) The assessment per front foot is comparable to the assessment per front foot of other property in the Village.

Mr. Davis therefore recommended that the assessment on Lots 9 & 10 remain the same.

Councillor Carter moved that the recommendation of the assessor be accepted and that the assessments of Lot 9 & Lot 10 Block 14 Plan 7711236 remain the same. Carried.
