MINUTES OF A SPECIAL MEETING OF THE COUNCIL OF THE VILLAGE OF BEISEKER HELD THURSDAY, MAY 1, 1980 AT 2:00 P.M. IN THE COUNCIL CHAMBERS

CALL TO ORDER

The meeting was called to order at 2:03 P.M. by Mayor Richter.

BUSINESS

The purpose of the meeting was to discuss the objections raised by taxpayers at the Public Hearing regarding By-law 80-3 held April 28, 1980.

Following a lengthy discussion it was the feeling of Council that:

- (1) perhaps re-zoning of the entire area could result in problems in the area as indicated by the taxpayers.
- (2) however, the redevelopment of Lots 15 & 16, Block 11, Plan 8292CH would also be beneficial to the Village at large.

It was therefore agreed that the Bylaw would be amended to redesignate Lots 15 & 16, Block 11, Plan 8292CH as R-2 but the remainder of the area would continue to be designated as R-1.

BYLAW 80-3

Councillor Rice moved second reading of BYLAW 80-3 amended to read as follows:

"NOW THEREFORE the Council hereby enacts as follows:

1. Section 8.3.0, being the Village of Beiseker Land Use Map, is amended by redesignating from Residential Single Family District (R-1) to Residential - Two Family District (R-2) the following described lands:

(a) Lots 14 & 16 Block 11 Plan 8292CH"

Carried Unanimously.

Councillor Carter moved third reading of Bylaw 80-3 as amended.

Carried Unanimously.

Mayor Richter moved the meeting be adjourned at 3:00 P.M.
