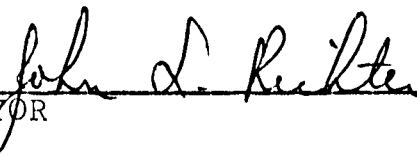
- (2) The Alberta Planning Board Hearing - January 1982
