The written appeal had indicated that Mr. Martin felt his property was assessed too high

Mr. Forrester commented that the property was assessed in accordance with comparable properties within the Village and recommended that no change be granted to the assessment.

Councillor Carter moved that no reduction to the assessment be granted in accordance with the recommendations of the assessor.

(b) 3:10 P.M. Don Coyne

Lot 13, Block 7 Plan 7710063

The appeal indicated that Mr. Coyne felt that his property was assessed too high. At the time of the annual assessment the garage was at a particular stage of completion. No additional work has been completed on the garage but the assessment was increased at the annual review December 31, 1982.

Mr. Forrester indicated that the garage should possibly have been assessed higher at the time of the 1981 general assessment. However recommended that the Court grant a small reduction since the garage was not finally completed.

Councillor Courtman moved the garage assessment on the property at Lot 13, Block 7 Plan 7710063 be granted a reduction: from 5,320 to 4,440 in accordance with the recommendation of the assessor.

Portions of Lots 9, 10, & 11 Block 2 Plan 4011X

Councillor Carter indicated his pecuniary interest in this property and indicated that he would not comment or vote on this appeal.

The reason for the appeal was that it appeared the assessment on the property was too high.

Mr. Forrester indicated that the land has been assessed as having 75 feet of frontage on Main Street i.e. measurement 75 x 75' when in fact the frontage on Main Street was only 30' making the property 30' x 75'. He therefore recommended a reduction in land assessment.

Councillor Fegan moved that the land assessment at portions of Lots 9, 10, & 11 Block 2 Plan 4011X be changed from 9,770 to 3,910 in accordance with the recommendations of the assessor.
