
NEW BUSINESS

(b) Watermain Problems - 9th Street

Problems with metal deterioration on the saddles <sup>where</sup> were service connections tie-into the watermain on 9th street between 2nd and 3rd avenue were discussed. It was agreed that another test hole at 9th street and 4th avenue just west of Fourth Avenue, the saddle at the first service connection will be inspected and a valve will be installed. If there is no metal deterioration at this location then an additional test hole will be dug on 9th Street just west of 3rd Avenue to determine if there is any further deterioration at the first service connection in this block.






