Councillor Stewart moved that prior to 2nd reading of Bylaw 89-19 being a bylaw of the Village of Beiseker to amend Land Use Bylaw 79-15 and taking into consideration information received at the Public Hearing held January 17, 1990 at 7:30 P.M. that Section 1 of the Bylaw not be amended.

Councillor Beagle moved that prior to 2nd reading of Bylaw 89-19 being a Bylaw of the Village of Beiseker to amend Land Use Bylaw 79-15 and taking into consideration information received at the public hearing held January 17, 1990 at 7:30 P.M. that Section 2 of the Bylaw be changed to read as follows:

Section 18.00 (General Industrial District (M-2) Land Use Rules) amend subsection 18.6.1 (Height of Buildings) to read:

18.6.1 Height of buildings

(a) Except as in (b) below: 9m (29.53 ft)

(b) The maximum height requirements for buildings as specified in (a) may exceed 9m (29.53 ft) to a maximum of 30.48m (100 ft) at the discretion of the Municipal Planning Commission if the additional height is required to house mechanical equipment for a manufacturing process essential to the operations of the principal use or is required for engineering or environmental protection reasons.
