CALL TO ORDER

Deputy Mayor L'Abbee called the meeting to order at 7:35 P.M.

ADOPTION OF AGENDA

Councillor Walters moved to approve the minutes of the Regular Meeting of the Council of the Village of Beischer held Monday, April 12, 1999. CARRIED UNAN.

PUBLIC WORKS ITEMS

. Well Purging

The Public Works Foreman informed Council of the price from Doering Drilling to purge the wells. This cost would include moving the house over the well in order to put the equipment into the well. Council asked Public Works to check in with M & M Drilling to see what their cost covered as far as purging the wells was concerned.

Public Works Foreman advised to contact the engineering companies given by Urban Systems with regard to the purging, redevelopment and flow testing of the existing well #5 and #7 and the possible drilling of a new well #6.

Garbage Truck

The king pins on the garbage truck have been installed.

Street Sweeping

Main street and second avenue were done in the evening and two days later the residential area was done. The City of Airdrie contracted with the Villages to do the street cleaning this year.

72" Toro mower

The 72" Toro mower has been repaired and is back now. Oak Creek advised that there is possibly two more years on the motor. The Public Works Foreman advised that Council may want to look at leasing equipment when the motor does go in this machinery as to purchase new would cost between \$40,000 and \$50,000. Public Works Foreman asked to check with Olds College to see if their students still rebuild motors.

Tourist Booth

The Public Works Foreman asked Council about the possibility of moving the Tourist Booth into the roadway at the Campground to restrict the flow of traffic in order to have them drive past the self check in for the campground.

Council was not in favour of moving the Tourist Booth due to the fact that there is electricity and telephone connections to the building but suggested that the Public

Signage

The Public Works Foreman advised Council that he would like to have all the signs in Town at a consistent height. The City of Calgary uses 7'6", Village of Irricana uses a height of 6'6". Council advised that this might be a good winter project to look in to but not at this time. Council also suggested that Public Works try double bolting the signs for now. Council also advised that when the poles are replaced they preferred the height of 7'6".

Transfer Bin #2

Public Works Foreman updated Council on the progress of putting the lid on the transfer bin #2. The lid is now in place, the hydraulies will be checked once it is wired.

CP Land

The Public Works Foreman asked what more Council would like to do the CP Property. Council advised Public Works to put all the debris remaining in a pile for now until Council decides what should be done as far as disposal is concerned.

Reservoir #2

The upgrade on Reservoir #2 was discussed with regard to the mortar in between the bricks. Through an information fax from Urban Systems they advised that one possible alternative would be to repoint the mortar rather than re-bricking..
