

**VILLAGE OF BEISEKER  
BYLAW NO. 2008-09**

**Being a bylaw of the Village of Beiseker, in the Province of Alberta, for the purpose of setting fees for services provided by the Village in accordance with the Municipal Government Act, Revised Statutes of Alberta, 2000, Chapter M-26 and amendments thereto:**

**WHEREAS**, in accordance with the Municipal Government Act, 2000, Chapter M-26., as amended; and the Freedom of Information and Protection of Privacy Act, S.A., 1994, Chapter F-18.5, as amended, a municipality must make certain information available to the public; and

**WHEREAS**, in accordance with the Municipal Government Act, and the Freedom of Information and Protection of Privacy Act, a municipality may pass a bylaw establishing fees to charge for providing information.

**WHEREAS**, in accordance with the Municipal Government Act, and amendments thereto, a municipality may pass a bylaw establishing fees to charge for providing goods and services.

**NOW THEREFORE**, the Council of the Village of Beiseker in the Province of Alberta, dully assembled , hereby enacts as follows:

**PART 1: BYLAW TITLE**

1. This bylaw shall be known as the “Fees and Rates Bylaw 2008-05”.

**PART 2: DEFINITIONS**

1. Chief Administrative Officer: shall mean a person appointed as Chief Administrative Officer under the municipal Government Act, 2000, Chapter M-26 and amendments thereto.
- 2 Council: shall mean the Council of the Village of Beiseker.
- 3 Village: the Municipality Corporation of the Village of Beiseker.
4. Formal Request: shall mean the request for information or service, which is not routinely provided.

**PART 3: APPLICATION**

Unless prior written approval is obtained from the Chief Administrative Officer, when information is released or services performed, or goods sold by the Village, the Village shall charge fees as established in Schedule A, attached hereto, which may be altered from time to time by resolution of Council.

Read a Second Time this 28<sup>th</sup> Day of July, 2008.

Given unanimous consent for Third and Final Reading this 28<sup>th</sup> day of July, 2008.

Read a Third and Final time this 28<sup>th</sup> day of July, 2008.

**Fees & Rates Bylaw 2008-09**  
**Village of Beiseker**

**1. Public Works Equipment and Personnel**

All prices include an operator from public works and all requests are subject to availability of personnel and equipment.

a) P/W Personnel with ½ ton – traffic control	\$55.00/hr.
b) P/W Personnel with 1 Ton – traffic control	\$65.00/hr.
c) Tractor with 6 foot mower	\$70.00/hr.
d) Backhoe	\$100.00/hr
e) 3 Ton Truck	\$100.00/hr.
f) 3 Ton Truck (plow and sand)	\$100.00/hr. + sand
g) Toro Ride Mower	\$80.00/hr
h) Weed Trimmers	\$35.00/hr
i) Post Hole Augur – (minimum 1/2 hour)	\$65.00/hr
j) Bobcat	\$130.00/hr
k) Sewer flusher	\$150.00/hr.
l) Land Leveller	\$70.00/hr.
m) Spray Weeds –	minimum \$40 + chemical per hour
n) Foreman on site	\$35.00/hr + O.T.
o) Assistant Personnel on site	\$25.00/hr + O.T.
p) Commercial water after hours	minimum \$30.00 call out plus water

**2. WATER**

Basic and minimum rate	18 cubic meters @ 4.47 or 80.46 bi-monthly
Over 18 cubic meters	4.47 per cubic meter

**3. SEWER**

Residential

Basic and minimum rate	29.00 bi-monthly

Commercial

Basic and minimum rate	63 cubic meters @ .4603 or 29.00 bi-monthly
Over 63 cubic meters	.43 per cubic meter of water used

**4. GARBAGE AND RECYCLING**
